WWBA TOURNAMENT RULES AND REGULATIONS

1. All bowlers must report, prepared to bowl, at **least 30 minutes** before scheduled time. Only the bowlers and the scorers are permitted in the bowling enclosures. A bowler arriving late will be allowed to bowl. Her score is to start with the frame in which she is ready to bowl, receiving zero for any missed frames. If one bowler is late for the doubles event, the entrant present will bowl her singles event first.
2. **Bowler MUST be a member of the WWBA (Wilmington USBC WBA) for the current 2011-2012 season.**
3. Averages: bowlers will use the **2010-11 USBC Highest Final Average** with 21 games or more. If no established 2010-11 average, the highest current 2011-12 USBC winter average as of **2/01/12**, for 21 games or more, verified by league secretary, will be used. Any bowler without an established average will bowl scratch (220).
4. **USBC Rule 319 (a, item 2) (10 pins higher) will not be in effect for this tournament.**
5. **Entry fee** for this tournament is \$20.00 per event per bowler (Bowling - \$9.00; Expenses - \$3.00; Prizes -\$8.00). The prize fund will be returned 100% with a ratio of at least 1 in 5. Optional HDCP All Events will be \$6.00 and the prize ratio will be at least 1 in 5. Optional SCRATCH All Events will be \$6.00 and the prize ratio will be at least 1 in 5. **LATE ENTRY WILL BE ACCEPTED after the close date if lanes are available.**
6. An entrant may participate in the team, doubles and singles event more than once. However, two members of the team must be different and doubles partner must be different. Bowlers entered in the doubles event must bowl the singles event. A bowler participating more than once in any event must count her **first** score in each even, for All Events. A bowler may cash multiple times in team/doubles/singles.
7. List bowlers in the order in which they are to bowl. Substitutes must bowl in the position vacated by the original entrant. A substitute will not be required to reimburse the entry fee paid nor shall the substitute be expected to give the original entrant any prize money or trophy she may win.
8. Div/HDCP: Team: Div 1 (641 & Over, HDCP Base: 880), Div 2 (640 & Under, HDCP Base 640)
 Dbls: Div 1 (321 & Over, HDCP Base: 440), Div 2 (320 & Under, HDCP Base 320)
 Sgls: Div 1 (161 & Over, HDCP Base: 220), Div 2 (160 & Under, HDCP Base 160)
 AE: Div 1 (161 & Over, Base: 220), Div 2 (160 & Under, Base: 160)
9. Handicap will be included in the All Events total. Bowlers entered in the team, doubles, and singles events may participate in All Events by paying the Optional All Events Fee of \$6.00 prior to the start of her 1st event. A bowler who places first in the HDCP All Events but who has not paid the optional fee is eligible to receive only the Championship Award for the All Events. A bowler can pay the optional HDCP and SCRATCH All Event fee, thus making her eligible for both events. The same scores will be used.
10. The tournament Committee may refuse to permit any team or individual to bowl if it is determined that there was an illegal or unethical entry.
11. Any appeal or protest concerning scoring shall be made in writing to the Tournament Secretary and must be submitted no later than twenty-four hours after the game has been played, briefly stating the grounds of appeal or protest. The action of the Board of Directors shall be final.
12. In the event of a tie for first place in any category, co-champions will be declared and additional awards will be given.
13. The acceptance of this entry by the Tournament Secretary constitutes an agreement by all entrants to abide by all rules and regulations prescribed by the USBC and the. Tournament Committee.

PRIZE CHECKS NOT CASHED WITHIN 60 DAYS OF ISSUE WILL BE NULL AND VOID.

The entrants whose names appear hereon or their authorized replacements hereby agree that the Wilmington USBC WBA, its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any schedule change or premature termination of the tournament, which may be brought about by war, national emergency or emergencies of cause relating thereto or resulting there from fires, strikes, lockouts, labor difficulties or other causes beyond the control of the WUSBCWBA.
