REQUIREMENTS FOR ALL CANDIDATES

Must have a working knowledge of USBC rules and regulations and Roberts Rules of Order.

OFFICER CANDIDATES

Must have been a DWBA/DEBA/DSUSBC director for a minimum of 2 full year and within a 5-year period preceding nomination.

DIRECTOR CANDIDATES

Must be currently a member of the Delaware State USBC association

DUTIES OF OFFICERS AND DIRECTORS

- Time to devote to **ALL** USBC meetings, **ALL** board meetings, **ALL** committee meetings and **ALL** days of the tournament
- **WORK** on **ALL** committees to which you are appointed
- Distribute and assist in preparation of materials (kits, sanctions, tournament entries and prize list, association awards, etc.)
- Assist in preparation, conducting and follow-up of annual tournament

Must be present at the annual meeting for which you are running for election. Excused absence only if participating in USBC National Tournament or Employment related.

Must be a member of USBC at time of election AND during term of office, and may **NOT** bowl in any unsanctioned leagues during your term of office.
